

Trade union facility time report 2018/19

Introduction

Trade Unions play an important role in the workplace and there are considerable benefits to both employers and employees when organisations and unions work well together.

Trade union representatives carry out a range of valuable duties and activities in an organisation, including:

- working with managers
- · communicating and consulting with staff
- · resolving problems and conflicts at work
- jointly developing workplace policies
- promoting workplace learning
- resolving health and safety issues
- handling disciplinary and grievance matters

Trade Union (Facility Time Publication Requirements) Regulations 2017

In line with the Trade Union (Facility Time Publication Requirements) Regulations 2017 which came in to force on 1 April 2017, all employers must publish information on facility time, which is agreed time off from an individual's job to carry out a trade union role.

There is a legal requirement to record and publish facility time for the period 1 April 2018 to 31 March 2019 and organisations are required to the information on their website by 31 July 2019.

The regulations state that employers must:

- publish the information in the form indicated in schedule 2 of the regulations
- place this information on their website before 31 July 2019
- include this information in their Annual Report which covers the relevant period (April 2018 to March 2019)
- place the information on a website maintained by or on behalf of the government before 31 July 2019

The purpose of the regulations is to promote transparency and to allow for public scrutiny of facility time.
